NOTE ON THIS SURVEY

The 1993 Population and Housing Census was conducted to count people where they stayed on the Census Night, the night of Thursday, April 15. It is proposed to determine how well people have been counted in the Census through this Post Enumeration Survey conducted soon after the Census in selected areas. This Survey is intended to estimate the error in the count which is inevitable in a large scale operation like the Census. In the first visit to households by PES Enumerator, a recount will be made in the Survey and this will be followed by a second visit to reconcile discrepancies.
